## Chinese Business Conference: Strengthening Saudi Arabia-China Economic Relations

## **Reviving the Silk Route for Regional Growth**

On the sidelines of the China-Saudi Arabia Business Conference, Saudi Arabia announced the revival of the Silk Route in an effort to further strengthen trade ties with China. While speaking at the event, Saudi Arabia's investment minister, Khalid Al-Falih, said that while China looks to strengthen its trade relations with the Arab world, the Kingdom may act as its gateway.
